RES.ART 25/26 - CHOREOGRAPHIC RESIDENCY AGREEMENT

This Choreographic Services Agreement ("Agreement") is entered into on [Date], ("Effective Date"), between VIVO CENTER ASD&APS, with its registered office at Via Felice Anerio 32, 00199, Rome, Partita IVA 13474741009, legally represented by its president _____, born in _____ on _____, Social Security Number: _____, hereinafter referred to as the "Host Organization,"

agree upon the following:

THE HOST ORGANIZATION will commit to supporting the work of the CHOREOGRAPHER with a creative residency from _____ at VIVO CENTER studio in Via Archiano 8, 00199 Rome.

1. Engagement of Choreographer

1.1 The Host Organization hereby engages the Choreographer to create a contemporary dance piece (the "Piece") as described below.

2. Scope of Services

2.1 The Choreographer shall create and choreograph a contemporary dance piece to be performed by the dancers of VIVO CENTER's young company (the "Dancers") within 10 working days.

For the purposes of this agreement, "working days" shall mean a day of activity consisting of a minimum of 5 hours, preferably scheduled as follows: 9:00 AM – 12:30 PM and 1:30 PM – 3:00 PM.

2.2 During the residency period, the Choreographer shall lead a 3-hour workshop open to non-professional participants (two classes of 1.5 hours each).

2.2 The Choreographer will work with the Dancers to develop the Piece, including but not limited to, choreography, movement, music selection (if applicable), and staging.

2.3 The Choreographer will collaborate with VIVO CENTER's Artistic Director and staff during the creation process.

3. Rehearsal Period

3.1 The rehearsal period will commence on November 4th through November 15th 2024, spanning 10 consecutive working days, excluding Sundays.

4. Intellectual Property

4.1 The Choreographer retains all intellectual property rights in the Piece, including but not limited to copyrights and any derivative works.

4.2 The Host Organization is granted a non-exclusive, royalty-free license to use, perform, and promote the Piece for its educational and promotional purposes.

4.3 Any photographic and video material produced during the residency shall be the property of the host Organization, which may distribute and publish it without any limitations.

The Choreographer shall be entitled to re-share such material, provided that the host Organization is always credited, in accordance with terms to be agreed upon in advance.

5. Performance (s)

5.1 The Host Organization agrees to schedule a performance of the Piece, to be held in the _____ in Rome on date _____

5.2 Any additional performances or presentations featuring the Piece will be communicated to the Choreographer in advance.

6. Reimbursement and expenses

6.1 The Choreographer acknowledges that this engagement is a non-profit activity, and as such, there shall be no compensation for the Choreographer's creative work.

A lump sum reimbursement of €750 will be paid to cover expenses incurred by the Choreographer for the creation of the choreography (e.g., travel expenses, meals, etc.).

This reimbursement will be paid as follows: 50% at the beginning of the residency as an advance, and 50% upon completion of the residency, as described in Article 2.

6.2 Should the Choreographer fail to complete the work in its entirety, they agree to return the full amount received and to pay an additional penalty of €1,000, which VIVO CENTER will allocate to another choreographer for the urgent staging of an alternative piece.

7. Costumes

7.1 The Choreographer will receive assistance from VIVO CENTER regarding costume design and selection.

7.2 The budget for costumes is separate from the expenses mentioned in Article 6, and the details of the costume budget shall be agreed upon during the creation period.

10. Governing Law

10.1 This Agreement shall be governed by and construed in accordance with the laws of Italy..
